

## PRIVACY POLICY

This document describes the privacy policy for **ces.org.ua** (hereinafter "the web-site") of non-governmental organization the Centre for Economic Strategy. This document provides information about the types of data that can be collected and stored on the web-site and how this data can be used.

### Collection and use of personal data

"Personal data" means data relating to a living individual who is or can be identified. The user may be asked to enter personal data to register on the web-site.

After filling in the form for receiving information and news from the Centre for Economic Strategy and also filling in the contact form that can be found on the web-site, it is considered that the user agreed to processing of personal data and contact details by the Centre for Economic Strategy. Centre for Economic Strategy can collect information about connection, traffic, date and duration of user's work on the web-site.

A user's personal data is used for providing exchange of information, relations in advertising and communications in accordance with the Laws of Ukraine "On Protection of Personal Data", "On Information", "On Advertising", "On Telecommunications", "On Business associations", "On Protection of Information in Informational and Telecommunication Systems", ND TIP 2.5-010-03 "Web information security requirements against illegal access".

A user's personal data can be stored for 3 years.

Domain names or user's computer IP-address, access date, files (file's name and URL), HTTP response codes and Web web-site, from which the user entered the web-site, the number of bytes, transferred during the session, are being recorded on the web-site.

Cookie files, which provide security functions are used during the web-site's work. Cookie files also allow to tracking violations of policy statements and terms of use by users/their devices.

With the use of Google Analytics, statistics such as visited pages, page views, downloaded information, Internet access provider's domains, user's country of access, web-site addresses which were visited before and after visiting the web-site, etc. are being collected. None of these actions are personally connected with users and are only measured in the aggregate.

### Auto acquisition

The following information is being automatically collected and stored:

- Domain name, IP-address whereby you enter the web-site;
- Type of browser and operating system;
- Date and time of visiting the web-site;

- Visited pages;

- If you followed a link to the web-site from another site - the address of the web-site.

Information about the traffic that passes through the network, emails, user activity on the Internet on the web-site is protected by law. It means that employees of Centre for Economic Strategy can not interfere in telecommunication confidentiality.

We are entitled to give any web-site user's personal information at the request of law enforcement authorities under a court decision or within the constraints of regular proceedings, or another lawful demand in accordance with the current legislation of Ukraine.

We will not be liable for loss of profits, loss of data or any other web-site user's losses if they occurred during web-site usage. A user visits the web-site at his/her own risk.
